EDITORIAL

The right to life for all

June 24, 2022 – the world was once again challenged to accept the rights of the unborn. In a landmark decision, the United States Supreme Court overturned its nearly 50-year-old decision in *Roe v Wade* that legalized abortion in the country. The 1973 *Roe v. Wade* had recognized that the right to personal privacy under the Constitution, protects a woman's ability to terminate her pregnancy, and legalized abortion nationwide.

The June 24 ruling has stirred up strong sentiments across the country and the world. After almost fifty years, the US Supreme Court has effectively come to the defence of the unborn, allowing states to enforce a ban on abortions. Merely minutes after the ruling, states across America began imposing a ban on abortions.

Pro-life activists rejoiced on hearing this judgement whilst pro-choice activists expressed disappointment. Many rights groups are calling the *Roe v Wade* decision as horrific and medieval and a vote against women reproductive justice and bodily anatomy. The verdict has been criticised by many world leaders and influencers. Some prominent personalities and politicians in our own country have been quick to denounce the ruling. On the other hand The Vatican's Pontifical Academy for Life praised the Supreme Court's decision on abortion saying it challenged the world to reflect on life issues whilst calling for social changes to help women keep their children. The verdict has reignited the commitment of all who had been raising their voice against abortions.

We all agree that deliberate killing of a human being is an act of murder. Yet we have a vast section of society which has no hesitation in asking for the right to kill an unborn child in the womb under the guise of women's empowerment and her right to choose. The baby in the womb does not seem to warrant any consideration. The current ruling has forced society to rethink on the meaning of life and humanity.

As voiced by Archbishop Paglia, President of the Pontifical Academy for Life, "In the face of Western society that is losing its passion for life, this decision is a powerful invitation to reflect on the serious and urgent issues by choosing life. It is a time for healing wounds and repairing social divisions; it is a time for reasoned reflection and civil dialogue, and for coming together to build a society and economy that supports marriages and families, and where every woman has the support and resources she needs to bring her child into this world in love."

India, though a religious nation, is not far behind western thinking when it comes to abortion issues. To aggravate the situation, we have a culture of preference for a male child often with deliberate attempts to abort a girl child.

As per a study published by The Lancet Global Health, the number of abortions in India is over 21 times higher than government reports. The government had been consistently reporting about 700,000, but that doesn't count private abortion clinics or self-administered "at home" chemical abortions. The study emphasized that 81 percent of abortion seekers take life-threatening drugs, killing their babies at home, without a doctor's supervision and many without even counselling.

The Church teaching holds that abortion is intrinsically evil, and as such is never justified. The same can be said for many other things such as rape, torture, euthanasia, and kidnapping (Gaudium et Spes para 27). Though an individual may have the best intentions, it does not justify an act that moral law and revelation have deemed evil.

It is now a time for serious introspection. Merely talking anti-abortion is definitely not enough. As a community, do we celebrate life by providing resources to young couples who look forward to starting their own families in these financially challenging times? We have to collectively challenge those who propagate female infanticide. Voices which have been silent for too long should be emboldened to speak up in defence of the unborn.

Our institutions need to be made easily accessible to women seeking help without feeling judged. We need to do more, to ensure that women in India are provided all the care and support to help with the delivery and subsequent care so that abortion ceases to be an option. In the measure we can, we are called upon to use our talents, time and resources to provide assistance to mothers, couples and the unborn child.

Pope Benedict XVI in his address to the Pontifical Academy for Life in Feb. 2011, very aptly stated, "Society as a whole must defend the conceived child's right to life and the true good of the woman who can never, in any circumstances, find fulfilment in the decision to abort."

Nothing surpasses the greatness or dignity of a human person...If a person's right to life is violated at the moment in which he is first conceived in his mother's womb, an indirect blow is struck also at the whole moral order - Pope John Paul II, October 7, 1979 in Washington D.C

Each one of us is called to respect, love, uphold, nourish and cherish all human life, especially the unborn life in the womb. The very being of the unborn is precious and wonderful- a true sign of love. We cannot ignore the discrimination that is taking place against the defenceless unborn babies. We cannot be talking of justice and equality in the human kind without taking into account the injustice being done to life in the womb. As a result, the foetus either continues to perish or is sacrificed at the altar of desperation and hopelessness. Few other reasons have always been cruelty, convenience, lack of integrity or extreme poverty.

Moreover, if one kills a pre-born sea turtle or a pre-born bald eagle, the person is heavily fined with an accompaniment of minimum 1 year imprisonment. However, there is no penalty levied on killing a pre-born human baby! Our ethics surely stand silent in the witness box of life! We are well acquainted to the 'Roe v Wade' shout for abortion being made legal. Thankfully, this long running tryst has now been addressed; and the Supreme Court has voted to overturn abortion rights. This has definitely provided some solace with reference to saving lives! It is heart wrenching to see that despite being a progressive society, we learn of pregnant women wronged, abandoned and left harassed with helplessness enumerating many direct or indirect reasons. We believe that life is sacred and thus nobody has the right to ooze out the sanctity of it. Thus, TSPF does its bit of supporting life. Firmly believing that life is precious and has a purpose attached to it, we undertake our work of protecting life. With pioneering efforts to address healthcare needs of pregnant women in poor and marginalized communities, our foundation has crossed many milestones to preserve life and humanity.
